Circular

State Appropriate Authority vide letter no. **F.No.9(10)65/PNDT/DFW/14/4308** dated 27.05.2015 in compliance to rule Rule 18(A)(7) of PC& PNDT Act and Rules has mandated the registration of Manufacturers/ dealers/ distributors/ Sub-distributors/ Refurbisher etc. for the sale/ purchase of ultrasound machine / imaging machine etc.

Manufacturers/ dealers will sell / buy back / repair USG machines / Imaging machine / any other machine capable of detecting sex and probes only to those clients/ clinics which are registered with the Appropriate Authority of the concerned district.


Section 3 (B) of PC& PNDT Act prohibits sale of ultrasound machine/ imaging machines etc. to person, laboratories, clinics etc. not registered under the Act.

Further, Rule 3 (A) of the PC&PNDT Rules 1996 also provisions for the sale of ultrasound machines/ imaging machines to a person / clinic registered under the Act.

In view of the various clarification being sought it has been observed that there have been discrepancies in regard to the sale and supply of the ultrasound machine where the name of the purchaser, billing address and place of delivery are different in the invoice provided by the company which reflects that the machines are being sold to a person not registered under the Act but are delivered to a registered centre in the name of unregistered person under PC&PNDT Act , which amounts to violation of above provision PC&PNDT Act and letter dated 27.05.2015.

In view of this all the Manufacturers/ dealers/ distributors/ Sub-distributors/ Refurbisher etc. are hereby directed to ensure that machines are sold, delivered and installed to a person/ clinic registered under PC& PNDT Act. All the details on the invoice should be in the name of the registered person/ clinics to whom the machine has been sold, delivered and installed.

The non-compliance in this regard will be viewed seriously and both buyer and seller will be held responsible for the violation of the provisions of the PC&PNDT Act & Rules.


