Sub: Record maintenance under PC & PNDT Act

Sir/ Madam,

This is in reference to order no. F. No. 9(4)/3/PNDT/DFW/04/Pt. File/2400-2417 dated: 01.06.2016 subject – record maintenance under PC & PNDT Act where it was directed to keep original referral slips at the centre and photocopies to be sent to the districts.

The Act clearly says a referral note to be made with indications and to be preserved with form F but lots of representations and telephonic feedback is being received that obstetricians are not making separate referral slips from both government and private and are recommending ultrasound on OPD cards, which can't be deposited at the diagnostic center.

So in the interest of patients point b) Referral Slips (original to be preserved at centers and photocopies to be sent to districts) may be read as *photocopies of the referrals slips may be preserved at the centre and sent to the districts.*
