**Sub: Identity Proof with address mandatory for ultrasonography & other prenatal diagnostic tests & procedures in Antenatal cases (Pregnancy) under PC & PNDT Act.**


Sir / Madam,

In reference to the meeting of the State Supervisory Board held on 5.10.15 under the chairmanship of Hon'ble Minister of Health of Delhi, wherein, it was decided that Identity proof having address proof should be made mandatory for getting the ultrasound or any other Pre Conception & Pre Natal Diagnostic test and procedures.

You are hereby requested to kindly disseminate the required information to all the registered centers in your respective district that the centers are required to keep a copy of ID Proof having address of the pregnant lady (copy of election card, Aadhar Card or Ration Card or any ID Proof) issued by Govt. Authorities or copy of ID Proof of the relative accompanying the pregnant lady wherever the ID proof of pregnant lady is not available. In case the pregnant women has changed her address recently, the ID proof available with her may be attached with a note on the address proof stating the same.

However, in exceptional cases, where ID card is not made available the medical services to the pregnant lady should not be denied but the same should be noted in the reports being submitted to the districts before 5<sup>th</sup> of every month giving details of such cases.


